"KIDS TIMEL TABLETS", taken once a day, reduce nervous excitement caused by vehicle sway and acceleration, and reduce or relieve the occurrence of dizziness, nausea and headache caused by motion sickness. If you use about 30 minutes before getting on a car, ship, airplane etc, you will be relieved from unpleasant motion sickness, thereby making travel and excursion more fun.

Meclizine HCI 33.3mg Antiemetic

Scopolamine Hydrobromide Hydrate 0.166mg Sedative

Anhydrous Caffeine 15mg Headache treatment

Uses

For the prevention and treatment of dizziness, nausea, headache associated with motion sickness.

Warnings

Do not use for child under 3 years old.

While taking this medicine, please do not take any of the following medicines.

Other medicines such as motion sickness medicine, cold medicine. antipyretics, analgesics, sedatives, antitussive expectorants, gastrointestinal analgesic antispasmodics, internal medicines containing antihistamine etc. (internal medicine for rhinitis, allergy medicine etc.).

Do not drive a motor vehicle or operate machinery after using this medicine. (Symptoms such as drowsiness, blurred vision, dazzling sunlight may occur)


