The main component, prednisolone valerate ester acetate, is a type of steroid drug called antedrug. Antedrug are medicines that exert their effect on the affected area of the skin surface and become less active when absorbed into the body.

Prednisolone valerate ester acetate and dipotassium glycyrrhizinate, which suppresses inflammation such as eczema and hives, are combined with diphenhydramine hydrochloride, crotamiton and lidocaine to reduce itching.

Panthenol promotes skin repair. Isopropyl methyl phenol has a bactericidal effect. l-menthol and dl-camphor give a refreshing sensation and reduce itching.

This medicine is a non-greasy, clear gel cream.

l-Menthol 3.5g.....	Give a refreshing feeling
dl-Camphor 1.0g.....	Give a refreshing feeling

Uses

Insect bites, Itching, Eczema, Dermatitis, Rash, Hives, Heat rash.

Warnings

[To be avoided]

(Failure to observe the following may result in the current symptoms worsening or adverse reactions occurring.)

1. Do not use for the next part:

- (1) A person who has the affected areas with chicken pox (water pox), Athlete's foot (Tinea pedis), Ringworm in the groin, etc. and/or who have purulent on the affected part.
- (2) Wound surface, around eyes, mucous membranes etc.

2. Please do not use it extensively on the face.

3. Do not use long-term continuously.

[Consultation]

1. The following persons should consult a doctor, pharmacist, or registered distributor before using this medicine.

- (1) A person undergoing medical treatment from a doctor.
- (2) A pregnant woman or a woman suspected of being pregnant.
- (3) A person with a medical history of being allergic to medicines and other substances.
- (4) The affected area is spreaded on the wide.
- (5) A person with wet or awful sore on the affected part.

2. The following symptoms may be adverse reactions to this medicine. If any of these symptoms occur, discontinue use immediately and consult a doctor, pharmacist, or registered distributor with the Japanese package insert.

Skin	Rash • redness, itching, blotch, swelling, irritation, heat on skin, dryness, irritability
Skin (Affected area)	Athlete's foot (Tinea pedis) • Ringworm in the groin by trichomonas, Acne, Purulent symptoms, persistent feeling of irritation

3. If symptoms do not improve after using between 5 and 6 days, stop using the medicine, bring this package insert, and consult a doctor, pharmacist or registered distributor.

Directions

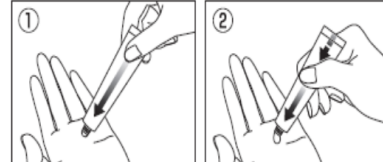
Apply an appropriate amount to the affected area several times a day.

[When using this product]

- (1) Please follow the recommended dosage and directions.
- (2) This medicine should be given to children only under adult supervision.
- (3) Be careful not to get into eyes. If it gets in your eyes, please wash immediately with water or lukewarm water. And If the symptoms are severe, please be given medical treatment by an eye doctor immediately.
- (4) Please use only for external treatment.

● Please push in order from the part of the tube (tail) to the tip.

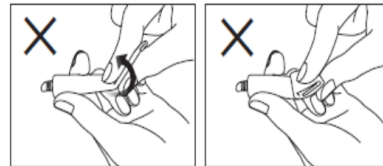

Other information

- (1) Store in a cool and dry with less humidity place free from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Do not get close to fire. In addition, please do not throw in fire after use.
- (5) Because this medicine contains volatile ingredients, please close the cap tightly after use.
- (6) Please do not touch your eyes or mucous membranes with your hand wearing this medicine.
- (7) Be careful not to adhere to metal objects such as glasses, watches and accessories, clothing, plastics, leather products, and painted surfaces such as floors and furniture, as they may deteriorate or discolor.

- (8) Do not use products that have expired. Please use as soon as possible from the point of quality maintenance even within the expiration date after opening.

1,3-Butylene glycol, Hypromese, Hydroxyethyl cellulose, Hydrophobic Hydroxypropyl methylcellulose, Ethanol, Citric acid hydrate, Sodium citrate hydrate.
