3. If symptoms do not improve after using between 5 and 6 days, stop using the medicine, bring the Japanese instructions written on this package case, and consult a doctor, pharmacist or registered distributor.

Directions

Apply an appropriate amount to the affected area several times a day.

[When using this product]

(1) Please follow the recommended dosage and directions.

- (2) This medicine should be given to children only under adult supervision.
- (3) Be careful not to get into eyes. If it gets in your eyes, please wash immediately with water or lukewarm water. And If the symptoms are severe, please be given medical treatment by an eye doctor immediately
- (4) Please use only for external treatment.

Other information

- (1) Store in a cool and dry with less humidity place free from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Do not use the product that has passed its expiration date (listed on the outer box).

Cetostearyl alcohol, Chain fatty acid triglyceride, Polyoxyethylene hydrogenated castor oil, Glycerin monostearate, Propylene glycol, Hydroxyethyl cellulose, Sodium edetate, Paraben, Phosphoric acid, Sodium hydroxide and Dibutyl hydroxytoluene.
