Diphenhydramine hydrochloride 2.0g....	Antihistamine action
Isopropyl methyl phenol 0.1g.....	Bactericidal ingredient

### *Uses*

Itching, Rash, Eczema, Insect bite, Dermatitis, Hives, Heat rash, Sores and Chilblains.

### *Warnings*

Itching caused by candidiasis, trichomoniasis, etc. requires radical treatment by a doctor.

### *[To be avoided]*

(Failure to observe the following may result in the current symptoms worsening or adverse reactions occurring.)

1. Do not use this medicine for the next person : If you suffer from candidiasis.
2. Please do not use for the next part : Around eyes, Mucous membranes etc.

## ***[Consultation]***

1. The following persons should consult a doctor, pharmacist, or registered distributor before using this medicine.
  - (1) A person undergoing medical treatment from a doctor.
  - (2) A pregnant woman or a woman suspected of being pregnant.
  - (3) A person with a medical history of being allergic to medicines and other substances.
  - (5) A person with wet or awful sore on the affected part.
  - (5) Infants.
2. The following symptoms may be adverse reactions to this medicine. If any of these symptoms occur, stop the use immediately and consult a doctor, pharmacist, or registered distributor with the Japanese instructions written on this package case.

3. The following symptoms may appear after using it, so if such symptoms persist or increase. Please stop using it and bring the Japanese instructions written on the package case, consult a doctor, pharmacist or registered distributor.

## ***Directions***

Apply an appropriate amount to the affected area several times a day.

### ***[When using this product]***

- (1) Please do not use while the affected area or its surroundings are dirty.
- (2) If you want to use it for children, please use under the supervision of parents.
- (3) Please be careful not to get into eyes. If it gets in your eyes, please wash immediately with water or lukewarm water. If the symptoms are severe, please consult an eye doctor.
- (4) Please use only for external treatment.
- (5) Please avoid using other external products at the same affected area.

## ***Other information***

- (1) Store in a cool and dry with less humidity place free from direct sunlight by a seal tightly.

- (2) Keep it out of reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Please do not use products that have passed the expiration date.

Polyoxyethylene hydrogenated castor oil,  
Parabens, Stearyl alcohol, Cetanol, Propylene
